# 1. Canvas of Election Returns.

City Secretary George reviewed for the City Council the election returns for the City Council General Election of Mayor and Councilmember Place No. 2. She reviewed the early voting totals, Election Day totals, and the combined Election Day totals. She also reviewed voting statistics including 67,275 registered voters and 51,482 total votes, which indicated a 76.5 % voter turnout. Votes cast by military overseas ballots (FPCA - Federal Post Card Application) and provisional ballots have been verified by the Early Voting Ballot Board and are included in the verified totals.
