ORDINANCE NO. 3415-8-16: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLINCOUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE, ASPREVIOUSLY AMENDED, BY AMENDING IN ITS ENTIRETY SECTION 6.06.11 "SOLAR PANELS"; PROVIDING A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A SAVINGS CLAUSE; PROVIDING FOR PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND (\$2,000) DOLLARS FOR EACH OFFENSE; AND PROVIDING FOR AN EFFECTIVE DATE.

ORDINANCE NO. 3416-8-16: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE AND ZONING MAP, AS PREVIOUSLY AMENDED, BY AMENDING THE DEVELOPMENT REGULATIONS, ADOPTING A CONCEPT PLAN, AND ADOPTING BUILDING ELEVATIONS FOR LOT 2R, BLOCK 1, ALLEN STATION BUSINESS PARK #2 (COMMONLY KNOWN AS 1379 ANDREWS PARKWAY), CITY OF ALLEN, COLLIN COUNTY, TEXAS, WHICH PROPERTY IS LOCATED IN AND SUBJECT TO THE REGULATIONS OF PLANNED DEVELOPMENT NO. 58; PROVIDING FOR A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.

MOTION: Upon a motion made by Councilmember Obermeyer and a second by Mayor Pro Tem Caplinger, the Council voted six (6) for and none (0) opposed to adopt Ordinance No. 3416-8-16, as previously captioned, to amend the Development Regulations and adopt a Concept Plan and Building Elevations for Lot 2R, Block 1, Allen Station Business Park #2, generally located north of Exchange Parkway and west of Andrews Parkway, for Simply Storage. The motion carried.

11. Conduct a Public Hearing on the Fiscal Year 2016-2017 Budget as Required by Article IV, Section 4.04 of the Allen City Charter.
