**MOTION:** Upon a motion made by Councilmember Sedlacek and a second by Councilmember Herald, the Council voted seven (7) for with Mayor Terrell, Mayor Pro Tem Caplinger, Councilmembers Kizer, Clemencich, Herald, Sedlacek and Brooks casting votes for and none (0) opposed that the property tax rate be increased by the adoption of a tax rate of 0.510000 which is effectively a 5.47 percent increase in the tax rate and to adopt Ordinance No. 3515-9-17, as previously captioned, setting that tax rate for the 2017-2018 Fiscal Year. The motion carried.
