PIGUES SURVEY, ABSTRACT NO. 702, THE FRANCIS C. - **MOTION:** Upon a motion made by Councilmember Kizer and a second by Councilmember Sedlacek, the Council voted four (4) for and three (3) opposed, with Mayor Terrell, Mayor Pro Tem Caplinger, and Councilmember Brooks casting the negative votes, to adopt Ordinance No. 3529-10-17 as previously captioned, amending the Planned Development Regulations, a Concept Plan, Open Space Plan, Sub-Area Plan, Phasing Plan, Sign Plan, Fire Lane Plan, and Building Elevations for a 79± acre tract of land; generally located at the southwest corner of the intersection of Stacy Road and US Highway 75, for Stacy Green. The motion carried.
