Although Lawn Star Landscape is our current vendor for these services, there has been inconsistencies with their Landscape bed maintenance, Irrigation maintenance, Lawn Care and Mulch areas throughout the course of the contract period. They have improved since the inception of the current contract, but their Lawn Care and Mulch areas are still not consistent. Their pricing is too low to cover the true cost of maintaing this contract. There were several plant removal tasks that were requested that were not completed on a timely basis. They did not bid on US 75 because the costs were too high to maintain, which is why their overall pricing appears lower than the others.

Marathon Resource Management did not provide any relevant work experience that was similar in scope to the proposal. Their pricing is too low to cover the true cost of maintating this contract. labor price of \$40/hour and submitted low prices on these properties: Raintree circle -\$88.50, Cabela Drive-\$92.00 and Courses at Watters Creek Club House Landscape beds-\$92.00. Based on their labor pricing they would only spending a couple of hours a month on these Properties. The pricing would not cover all of the other requirements in the bid specifications for these properties such as Lawn Care, Mulch, Ground Cover /Shrub beds, Weed prevention, Irrigation maintenance and Litter Maintenance. They did not provide references that were similar in scope to the proposal submitted. Also, they are based out of state and all their work will be subcontracted out, which would mean too many points of contact to deal with when issues need to be corrected.
