The following items take precedence over the initial bid specifications, where supplemented herein. The original requirements, not affected by this addendum, shall remain in effect.

#### Clarification:

- Page 13 #8-City Hall, McPar Building and Civic Plaza This item will be bid as labor only. Mulch will be provided by COA-COA staff used 240 labor hours to mulch this site
- Page 14 #7. Bethany Dr. East and 12. Main Street East -There are many Hardscape Medians -are any medians that have rock, pavers or are solid concrete.
- 3. Where the acres are given there are items to be taken in to consideration-If lawn care is included the acres include Hardscape, lawn and landscape areas. If lawn care is not included, then the acres only include hardscape areas and landscape beds.US 75, City Hall. McPar Building, Civic Plaza and the Courses at Watters Creek Club House Landscape beds and Futures Course Love Grass beds the acres are for the landscape beds only.
- 4. Page 15- General Labor provide general labor to be supplied for landscape services, mowing Contractor shall provide general labor to be supplied for landscape services, mowing services, playground engineered wood fiber replenishment and special event related activities. on an as needed basis as directed by the Contract Supervisor. Which may include but are not limited to forestry work. landscape, mowing services leaf removal, litter/debris removal, flood/storm debris removal, storm recovery and special event preparation/setup/operation/takedown/cleanup. Construction cleanup. Site under brushing and debris removal. All power tools, hand tools and trailers and any other equipment needed to perform the job will be provided by the contractor and should be included in the hourly price as well as any fees associated with landfill fees. Make sure hourly price reflects the cost to provide tools and equipment.

  - C. Debris / Litter Cleanup: 1. Debris a. Debris removal is to be conducted five days a week. -Monday-Friday, at all Event Center Sites.
- Page 20-Irrigation System- \* All Master Valves must be turned on which is the vertical position prior to Testing and turned Back to AUTO which is the horizontal position. All control valves must be bleed on Manually with the bleeder switch and not the solenoid.
- 9. Mulch Areas / Granite Areas / Hardscapes:
  - B. General Maintenance
    - Mulch application once a year to maintain a minimum 3-inch depth. At all Landscape beds. Only at City Hall, Civic Plaza and McPar building -Landscape beds-the City of Allen will provide mulch.
- Additional Facility Site: <u>Spirit Park-12,265 square feet</u> -1151-Ridgeveiw Drive- Maintain all Weeping Love Grass Beds. <u>Lawn Care, Irrigation and Tree Care will not be required /included in this bid</u> /contract for this property.
- 11. US 75-20,000 square feet or .46 acres of Weeping Love grass beds were converted to rock beds.

#### QUESTIONS/ANSWERS:

- Is the native grass area in the beds along Highway 75 going to require mulch in this bid? Or is it the open bed areas with planting material and trees rings that require mulching?
   Answer: Yes, all of the Native grass areas (Love Grass beds) and the tree rings.
