SUBJECT: REPLACEMENT VEHICLES



On May 5, 2019, Allen Police Department vehicle #703 (A 2017 Chevrolet Tahoe marked police car) was involved in a major accident. The vehicle was engaged in a pursuit of a felony suspect and lost control striking a pole. According to the City's Risk Manager, the vehicle is a total loss due to the significant amount of damage caused in the collision.

On May 14, 2019, Allen Police Department vehicle #702 (A 2017 Chevrolet Tahoe marked police car) was involved in a major accident. The vehicle was attempting to catch a traffic violator when another vehicle failed to yield right-of-way striking the passenger front end of this unit. According to the City's Risk Manager, the vehicle is a total loss due to the significant amount of damage caused in the collision.


The police department is requesting to replace these vehicles with two 2019 Chevrolet Tahoes (Tarrant County Contact pricing is \$34,303.44). The cost for installation and new/replacement equipment is \$9,882.29 per vehicle). Total costs \$88,371.46 and it is anticipated that the settlements will be approximately \$60,000 for both vehicles.

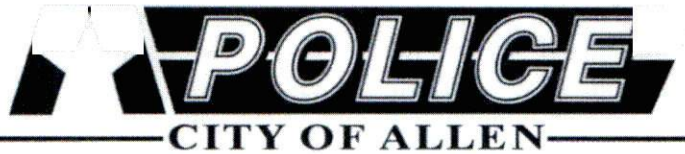

The police department is requesting to replace this vehicle with a 2019 Chevrolet Tahoe (Tarrant County Contact pricing is \$32,985.00). The cost for installation and new/replacement equipment is \$9,882.29 per vehicle). Total costs \$ 42,867.29.
