ORDINANCE NO. 3675-6-19: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE ZONING REGULATIONS AND ZONING MAP, AS PREVIOUSLY AMENDED, BY AMENDING THE DEVELOPMENT REGULATIONS FOR A 7.329± PORTION OF “TRACT 3” IN “PD” PLANNED DEVELOPMENT NO. 40 AS ESTABLISHED BY ORDINANCE NO. 751-10-86, AS AMENDED, AND ADOPTING A CONCEPT PLAN AND BUILDING ELEVATIONS; PROVIDING A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING FOR AN EFFECTIVE DATE.

MOTION: Upon a motion made by Mayor Pro Tem Caplinger and a second by Councilmember Brooks, the Council voted six (6) for and one (1) opposed, with Councilmember Doherty casting the negative vote, to adopt Ordinance No. 3675-6-19, as previously captioned, to amend the Development Regulations of Planned Development No. 40 Corridor Commercial and adopt a concept plan and building elevations for the property generally located south of State Highway 121 and west of N. Watters Road for Ally Outfitters. The motion carried.

ORDINANCE NO. 3676-6-19: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE AND ZONING MAP, AS PREVIOUSLY AMENDED, BY AMENDING ORDINANCE NO. 3452-2-17 GRANTING SPECIFIC USE PERMIT NO. 152 TO EXPAND THE PORTION OF THE BUILDING LOCATED ON LOT 1, BLOCK A, ALLEN BUSINESS CENTER II (ALSO KNOWN AS 718 S. GREENVILLE AVENUE, SUITE 150) WHICH MAY BE USED FOR A GYMNASTICS AND SPORTS TRAINING FACILITY USE IN AN APPROXIMATELY 20,866± SQUARE FOOT PORTION OF THE BUILDING; PROVIDING A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.

MOTION: Upon a motion made by Councilmember Doherty and a second by Mayor Pro Tem Caplinger, the Council voted seven (7) for and none (0) opposed to adopt Ordinance No. 3676-6-19, as previously captioned, amending Specific Use Permit No. 152 for a Gymnastics and Sports Training Facility use for Alliance Cheer. The motion carried.

9. **Conduct a Public Hearing and Adopt an Ordinance to Establish a Planned Development Zoning District with a Base Zoning of Corridor Commercial and to Adopt Development Regulations, Concept Plan, Building Elevations, and a Landscape Plan for the Property Generally Located South of Ridgeview Drive and West of U.S. Highway 75. [Tractor Supply]**

It was noted that Ms. George had accepted and verified written opposition from a property owner within 200 feet of the zoning request property and Mr. Kurbansade, Director of Community Development, has confirmed that 23.95% of the 200-foot protested area was computed. The Council must have a super majority vote in order to approve the zoning request as required by Section 4.06, Changes and Amendments, of the Allen Land Development Code.

The motion failed.

ORDINANCE NO. 3677-6-19: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE ZONING REGULATIONS AND ZONING MAP, AS PREVIOUSLY AMENDED, BY AMENDING THE DEVELOPMENT REGULATIONS FOR A 9.114± ACRE PORTION OF "PD" PLANNED DEVELOPMENT NO. 45 AND ALL OF SUB-AREA 1 AS ESTABLISHED BY ORDINANCE NO. 3529-10-17, AS AMENDED, AND ADOPTING A BASE ZONING OF TOWNHOME RESIDENTIAL "TH"; ADOPTING A CONCEPT PLAN, BUILDING ELEVATIONS, OPEN SPACE AND SCREENING PLAN, LOT TYPICALS, AND CROSS SECTIONS; PROVIDING FOR A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.

MOTION: Upon a motion made by Councilmember Schulmeister and a second by Councilmember Doherty, the Council voted seven (7) for and none (0) opposed to adopt Ordinance No. 3677-6-19, as previously captioned, to amend the Development Regulations of Planned Development PD No. 45 Shopping Center and adopt a base zoning of Townhome, Concept Plan, Building Elevations, Open Space and Screening Plan, Lot Typical, and Cross Sections for Lot 7, Block B, Stacy Green, for Cambridge Townhomes at Stacy Green, with the deviation of the Concept Plan from the applicant. The motion carried.

11. Adopt a Resolution Amending the Building Permit and Inspection Fees Associated with Residential Dwellings.

RESOLUTION NO. 3678-6-19(R): A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, ESTABLISHING ANNUAL CONTRACTOR REGISTRATION FEES IN ACCORDANCE WITH CHAPTER 4 OF THE CODE OF ORDINANCES AND SECTION 3.10 OF THE ALLEN LAND DEVELOPMENT CODE, AS AMENDED, AND BUILDING PERMIT AND INSPECTION FEES PURSUANT TO ARTICLE III OF THE ALLEN LAND DEVELOPMENT CODE, AS AMENDED; AND PROVIDING FOR AN EFFECTIVE DATE.

MOTION: Upon a motion made by Mayor Pro Tem Caplinger and a second by Councilmember Clemencich, the Council voted seven (7) for and none (0) opposed to adopt Resolution No. 3678-6-19, as previously captioned, amending the building permit and inspection fees associated with residential dwellings.
