ORDINANCE NO. 3684-7-19: AN ORDINANCE AUTHORIZING THE ISSUANCE OF "CITY OF ALLEN, TEXAS, TAX NOTES, SERIES 2019"; LEVYING A CONTINUING DIRECT ANNUAL AD VALOREM TAX FOR THE PAYMENT OF SAID NOTES; AND RESOLVING OTHER MATTERS INCIDENT AND RELATED TO THE ISSUANCE, SALE, PAYMENT, AND DELIVERY OF SAID NOTES, INCLUDING ESTABLISHING PARAMETERS THEREFOR AND DELEGATING MATTERS RELATING TO THE SALE AND ISSUANCE OF THE NOTES TO AUTHORIZED CITY OFFICIALS

ORDINANCE NO. 3685-7-19: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE ZONING REGULATIONS AND ZONING MAP, AS PREVIOUSLY AMENDED, RELATING TO THE USE AND DEVELOPMENT OF 11.651± ACRES OF LAND SITUATED IN THE PETER WETSEL SURVEY, ABSTRACT NO. 990 AND LEWIS WETSEL SURVEY, ABSTRACT NO. 978, PRESENTLY ZONED AS PLANNED DEVELOPMENT PD NO. 6 SHOPPING CENTER "SC" AND COMMUNITY FACILITIES "CF" BY CHANGING THE ZONING TO CREATE PLANNED DEVELOPMENT "PD" NO. 140 WITH A BASE ZONING OF COMMUNITY FACILITIES "CF"; ADOPTING A CONCEPT PLAN AND BUILDING ELEVATIONS; PROVIDING A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS

CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING FOR AN EFFECTIVE DATE.

MOTION: Upon a motion made by Mayor Pro Tem Caplinger and a second by Councilmember Brooks, the Council voted seven (7) for and none (0) opposed, to adopt Ordinance No. 3685-7-19, as previously captioned, to establish Planned Development PD No. 140 with a base zoning of Community Facilities "CF" and adopt a Concept Plan, and Building Elevations for property generally located south of Rivercrest Boulevard and east of Greenville Avenue.
